Shuttle

Outward journey:

- Pick-up time at the train station Bad Gastein: 7:05 pm

The shuttle will wait max. 5 minutes.

Return trip:

• Pick-up time at the parking lot in front of Valeriehaus: 10:15 pm *The shuttle will wait max. 5 minutes.*

Booking conditions

By booking the Full Moon Dinner on one of the dates set by the event-organizer, the given number of seats is reserved for the guest.

The price per person is € 138,00.

The booking is only binding when the total amount has been paid to the Tourist Office Bad Gastein. The invoice for the Full Moon Dinner will be sent to the guest following the booking by e-mail, mail or in person.

If the Tourist Office Bad Gastein does not receive an inpayment or confirmation of payment up to 5 days before the event, the reserved seats will expire.

Alternative date

Cancellation

If the Full Moon Dinner cannot take place on the original date and the alternative date due to force majeure (bad weather etc.), the guests will be informed by the Tourist Office Bad Gastein at least 1 day before Dinner. In this case the guests will be given the opportunity to postpone their booking to another date (if there are enough seats available) or the money will be refunded.

Number of participants

The minimum number of participants per event is 80 people. Should the number of participants not been reached, the event-organizer reserves the right to cancel or postpone the event up to 5 days before the event takes place.

If the number of registrations exceeds the number of available seats, they will be put on a waiting list according to the time of entry. The guest will be informed immediately.

Cancellation policy

In case of cancellation by the guest between the 14th day and the day of the Full Moon Dinner, the guest is obliged to pay the following cancellation fees:

- Until 2 weeks before the Full Moon Dinner: free cancellation
- 13 days to 5 days before the Full Moon Dinner: 50 % of the total amount

If the guest will be booking the Full Moon Dinner between 13 days and 2 days before the event, the booking can be cancelled free of charge within 24 hours.

Data protection notice
